Description: Grants of \$500 to USA and Canada individuals who have been impacted by the Coronavirus (COVID-19) crisis. Funding is intended to provide financial relief to beauty professionals who can not work due to the pandemic. Grant funds may be used for urgent needs such as bills and food.

Additional Eligibility Criteria:

Licensed beauty professionals are eligible to apply.

If you personally have access to funds, remember there are many workers in the industry who will rely on this aid. Only apply for funds if you are really in need. Those participating in individual or salon-based fundraisers for COVID-19 relief (i.e. a GoFundMe for your salon) are not eligible to apply. If you are receiving unemployment benefits, SBA loans and other government benefits you are still eligible.

Pre-Application Information: Applications will be reviewed on a daily basis Monday through Friday. Applications will be funded with a lottery system as donations are received so that all eligible applicants have an equal chance of receiving aid.

Due to growing concern for the staff's ability to work onsite with quarantines, potential mail disruption, business closures & overall need to speed up funding delivery, the payment delivery approach will be an electronic gift card.
