Description: Grants of \$1,500 to USA artists, collectives, groups, and ensembles for urgent needs related to the novel coronavirus (COVID-19). Funding is intended to assist experimental artists whose exhibitions and performances have been cancelled or postponed due to coronavirus.

Full Description:

In light of the impact of the COVID-19 pandemic on the artist community, the Foundation for Contemporary Arts is creating a temporary fund to meet the needs of experimental artists who have been impacted by the economic fallout from postponed or canceled performances and exhibitions. If you are seeking relief for a canceled performance or exhibition due to COVID-19 you can apply for support from the COVID-19 Relief Fund.

Estimated Size of Grant: \$1,500

Eligibility:

- See RFP and/or Grant Guidelines for full eligibility

Additional Eligibility Criteria:

- Applicants must be living in the United States or U.S. territories and have a U.S. Tax ID Number (SSN, EIN, ITIN, or other)
- Applicants must be individual artists, or an individual representing an artist collective, ensemble, or group. Curators, producers, workshop organizers, organizations, or arts presenters are not eligible to apply.
- In accordance with the FCA mission, FCA will continue to focus its support on artists making work of a contemporary, experimental nature.
- For the purpose of providing COVID-19 relief, FCA is temporarily suspending the three year waiting period between grants. If you have received a grant from the Foundation in the past three years you may apply for COVID-19 relief.
- Relief will be provided to artists who can demonstrate that they have had an engagement canceled or postponed due to the COVID-19 pandemic.
