Candidacy for assistance depends, among other factors, on the availability of funds and the number of eligible applicants, along with the following criteria:

The applicant must be a musician who has regular public performances, or performed on at least three widely released recordings (audio or audiovisual), or written music that has been performed on three widely released recordings, or published on three occasions. The term "Musician" includes vocalists, songwriters, composers, arrangers, and instrumentalists.

The applicant must demonstrate financial need. Sweet Relief may request tax returns, bank statements, and/or any other information deemed necessary to verify such need.

**Pre-Application Information:** A limited amount of funds are available to be used specifically for musicians and music industry workers affected by the Coronavirus.
