Description: Grants of \$1,000 to USA individuals who have been impacted by the Coronavirus (COVID-19) pandemic. Funding is intended to provide financial relief to beauty professionals and students who are unemployed. Eligible applicants live in locations that have mandated the closure of non-essential business and are currently not earning an income.

Full Description:

Generously funded by the Horst Rechelbacher Foundation, these grants will provide financial assistance to beauty professionals or students of beauty programs, whose lives have been drastically changed by the mandated closures in response to COVID-19. Available to beauty professionals and students who are unemployed and cannot maintain their regular income during this time, these grants will be distributed directly to the applicant to provide temporary financial relief.

Estimated Size of Grant: \$1,000

Eligibility:

- See RFP and/or Grant Guidelines for full eligibility

Additional Eligibility Criteria:

To Qualify Applicants Must:

- Be a resident of the U.S.
- Be a licensed beauty professional and have been employed for 12 months on or before March 16, 2020. OR They must have been attending a program to become a licensed beauty professional on or before March 16, 2020.
- Live in a State or County that has mandated the closure of non-essential business.
- Must currently not be earning an income.
- Must be a licensed professional OR future professional receiving licensure in: cosmetology, esthetics, massage or barbering in the US.

Pre-Application Information: Applications are open starting April 1, 2020. Applicants who have successfully submitted an application will find out if they're qualified by May 11, 2020. Applicants who are chosen to receive the grant will be contacted by May 22, 2020.
